

ELECTORAL ASSEMBLY

An Assembly of the Electors of the Parish of Trinity was held at the Parish Hall on Tuesday 19th April 2022 for the following business :-

A nomination meeting at 7.00pm to elect one Centenier to complete a 3 year term of office expiring in June 2025; and

A nomination meeting at 7.15pm to elect one Centenier for a term of office expiring December 2023, due to the resignation from the role of the holder of that office.

The Connétable welcomed the Assembly to the meeting. Apologies were received from Reverend G Houghton, Mrs A Pryke, Centenier J Howell, Centenier D Owen, L du Feu, and Vingtenier C Fossey.

It was noted that the draft Minutes of the previous Electoral Assemblies held on 17th November 2020 and on 12th August 2021 had been made available to the Assembly in accordance with the terms of the Notice. The Minutes of the Assembly on 17th November 2020 were adopted on the proposition of Mr J H Moulin and seconded by Mr C Bray, and the Minutes of the Assembly on 12th August 2021 were adopted on the proposition of Mr J Le S Gallichan Snr and seconded by Mr D Reynolds.

Before asking for nominations for the first position of Centenier, the Connétable thanked Dennis Owen who had previously filled the role.
