## PARISH ASSEMBLY

An Assembly of the Principals and Electors of the Parish of Trinity was duly convened and held in the Parish Hall on Thursday 9<sup>th</sup> November 2023 at 7:15 pm for the following business:

- 1. Appoint two Constable's Officers, one for the Vingtaine of Rozel and one for the Vingtaine of Croiserie.
- 2. Receive a verbal financial progress report on the costs of the work at the Rectory to date.

The Connétable welcomed everyone to the Assembly. Apologies were received from Deputy A Howell, Mr P R Williams (Procureur), Centenier O Simmons, Mr S Boas and Mrs A Boas.

The Convening Notice was read.

It was noted that the Minutes of the previous Parish Assembly held on 20<sup>th</sup> April 2023 had been made available to the Assembly in accordance with the terms of the Notice. The Minutes of the Assembly on 20<sup>th</sup> April 2023 were adopted on the proposition of the Rector and seconded by Mr J Moulin.

1. Constable's Officer – Rozel

Before asking for nominations, the Connétable thanked Mr S Boas for his service as Constable's Officer since November 2020.

On the proposal of Deputy E Millar and seconded by Mrs A Le Sueur, Mr Boas was re-elected as Constable's Officer. The Connétable informed the meeting that he would be writing to His Majesty's Attorney General regarding a date for Mr Boas to attend the Royal Court to take his oath of office.

Constable's Officer – Croiserie

Before asking for nominations, the Connétable thanked Mrs A Boas for her service as Constable's Officer since November 2020.

On the proposal of Mr C Bray and seconded by Mr J Moulin, Mrs Boas was re-elected as Constable's Officer. The Connétable informed the meeting that he would be writing to His Majesty's Attorney General regarding a date for Mrs Boas to attend the Royal Court to take her oath of office.

2. The Connétable reminded parishioners that, at the Rates Assembly in July, a budget of £50,000 was approved to cover the costs of erecting scaffolding and redecorating

the external fabric of the Rectory. It had also been agreed that, while the scaffolding was in place, any repairs required to the roof would be undertaken. The Connétable reported that, following inspection, the flat roof at the Rectory had been re-covered and that decayed timber on the facia boards had been discovered and replaced. Work had also been undertaken to the eaves in order to preserve the timber. The Connétable informed the meeting that while invoices were still expected, he envisaged that approximately £35,000 had been spent to date and the road side fence still needed to be repaired.

There being no further business, the Connétable thanked all for attending the meeting and the meeting was declared closed at 7:25pm.
