

PARISH ASSEMBLY

An Assembly of the Principals and Electors of the Parish of Trinity was duly convened and held in the Parish Hall on Thursday 13th June 2024 at 7:00 pm for the following business:

1. Elect a Vingtenier for the Vingtaine of Augrés, there being a vacancy.
2. Elect a Vingtenier for the Vingtaine of Rondin, there being a vacancy.
3. To (i) consider an application by Mr James Godfrey to the Bailiff for a Bailiff's Annual Entertainment permit for the RJA&HS Royal Jersey Showground, La Route de la Trinité, Trinity to hold a variety of events; and (ii) to decide whether or not to recommend to the Bailiff that the application be granted, providing reasons in either case.

The Connétable welcomed everyone to the Assembly. Apologies were received from Mr P Williams, Vingtenier C Fossey and Mr B Dorrington.

The Convening Notice was read.

It was noted that the Minutes of the previous Parish Assembly held on 23rd May 2024 had been made available to the Assembly in accordance with the terms of the Notice. The Minutes of the Assembly on 23rd May 2024 were adopted on the proposition of Deputy A Howell and seconded by Deputy M E Millar.

Before proceeding to the election of Vingteniers, the Connétable thanked Mr Joao Dias for his 4 years' service as Constable's Officer and Vingtenier and presented him with an illuminated address.

1. Mr John H Moulin proposed the re-election of Mr Charles Fossey to the role of Vingtenier for the Vingtaine of Augrés, which proposal was seconded by Mr B Rondel. In his absence, Mr Fossey was thanked for his willingness to be re-appointed. The Connétable informed the meeting that Mr Fossey would be sworn in before the Royal Court on Friday 26th July 2024 at 10am.
2. Mrs Sarah Nugent proposed the election of Mrs Alissa Ozouf to the role of Vingtenier for the Vingtaine of Rondin, which proposal was seconded by Deputy A Howell. Mrs Ozouf was congratulated on her promotion and was warned to appear before the Royal Court on Friday 12th July 2024 at 10am to be sworn in.
3. Public Entertainment Permit – RJA&HS Royal Jersey Showground. The Connétable invited Mr James Godfrey to present his application to the Assembly. Following a short discussion, it was agreed that the venue was important for the Parish and Island in hosting a wide variety of private and public events, many of which could not take place if the venue was not available. The meeting unanimously agreed to support the application and the Connétable confirmed that he would write to the Bailiff with the decision.

There being no further business the Assembly was declared closed at 7.15pm.
